**DIRECTIONS**

**From Interstate 4: Exit 27 – Polk Parkway.** Take Polk Parkway to first exit (Exit 3), 25-cent toll (EXACT CHANGE), right on Airport Road. Go 1 mile to 2nd traffic light, left on Drane Field Road, 4/10 mile to Century Boulevard, turn left (across from airport – Renna Enterprises on corner), left at 4th driveway into warehouse complex, go to back building. IPOC Dog Training sign on building.

**From Highway 60 (Bartow):** US 98 North to Polk Parkway West. Exit at Waring Road, left at the light, go under Parkway to 2nd traffic light. Turn right on Drane Field Road, go about 1 mile, turn right on Century Boulevard (Renna Enterprises on corner), left at 4th drive into warehouse complex, go to back building. IPOC Dog Training sign on building.

### **IMPORTANT EXHIBITOR INFORMATION:**

It is your responsibility to provide complete and correct information. Your dog's height and jump division must appear on the Entry Form. Your entry must specify whether your dog is entered in the A or B class for both Beginner and Intermediate. Trials will be run concurrently.

**Trial entry confirmations will be emailed to all exhibitors. Please read to ensure your entry is correct.**

Please make sure your email address is legible and is an email account you check regularly. If you sent an entry and did not get a confirm, please check your spam mail.

**Your dog's UKC registration number must appear on the Entry Form. Temp numbers are available on the UKC website. Pending numbers can not be entered.**

These trials will be conducted according the Official UKC Rules and Regulations. Dogs must be registered with the UKC in order to participate. Registration forms are available from UKC ([www.ukcdogs.org](http://www.ukcdogs.org)). Mixed breeds are welcome in the UKC. Official UKC Rules and Regulations are available from the UKC.

These trials will be held indoors in an air-conditioned facility, fully matted and gated.

### **Refunds:**

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or the trial is cancelled due to storms, hurricanes, or conditions injurious to our exhibitors and spectators. Bitches in season after entries close may have entry fees refunded, **less \$5**, provided the Trial Secretary receives notification, in writing by email, by the day before the trial. No other refunds will occur after closing date.

Please leave the grounds in the condition you found them.

**Please put a cut mat under your crate and chair. Mat sections are available near the left door to the front entrance.**

Dogs cannot be left in the building overnight, but you may leave your crates and chairs. No smoking allowed in the building. Children must be supervised at all times. Please park in designated areas and respect other tenants' space in the complex. Do not park on the paved area directly across from our building- it is an active driveway. Do not block large roll up doors on Saturday as most of the businesses are open on Saturday.

**IMPORTANT:** Dogs not in the ring must be on leash or crated at all times. Handlers are responsible for cleaning up after their dogs. There is a fenced exercise area available. **DO NOT POTTY DOGS ANYWHERE OTHER THAN THE FENCED AREA.** Handlers in violation of this policy may be excused by the Trial Committee without benefit of refund

- All UKC Performance events are open to any UKC registered dogs and dogs with a valid Performance Listing/Limited Privilege number, with the exception of Lure Coursing and Drag Racing. Please see the rules for each event regarding eligibility.
- We want you to keep the points earned at UKC Licensed events.**  
Important things to remember:
  - Dog not UKC registered? Apply for a Temporary Listing Number (TL) online at [www.ukcdogs.com/tl-numbers](http://www.ukcdogs.com/tl-numbers). (TL fees are non-refundable, non-transferable and do not apply to the cost of permanent registration.)
  - All dogs entering UKC events must be permanently registered, have a valid Temporary Listing Number, or a Performance Listing/Limited Privilege number.**
  - All entry forms must be completed and signed. Incorrect information submitted on the entry form may invalidate your wins.
