Charge will be for 4 days). Each power box on the fairgrounds will be designated with a letter. Please review the map and legend to make selections for potential camping sites. Each power box has a different configuration of 30 and 50 amp services. In the space provided make your top three (3) preferences or select "No Preference". Camping spots will be allocated as reservations are received in the fair office. Campers not making reservations may have to wait for availability.

(Box E does not have water available)


Power Box C/D- Five (5) 50 Amp Services & One (1) 30 Amp Service

- Camping is on a first-come-first-served reservation basis. No refunds will be issued unless
 written notice is received at least five days prior to the start of the show.

Vendor Insurance Requirements:

You are required to furnish satisfactory evidence of liability insurance, including a copy of the endorsement adding the Manatee River Fair Association, Inc. and Manatee County as an additional insured. The required minimum limits of liability are: Bodily injury liability with limits of \$1,000,000.00 per occurrence, and \$1,000,000.00 for property damage per occurrence. A certificate evidencing coverage will be required no less than 2 weeks prior to the event.

Also, vendors must notify the fair office of their intent to be a vendor for a specific event held on the Manatee County Fairgrounds no less than 2 weeks prior to the event. Please notify the fair office by phone or e-mail. Failure to comply with insurance and notification will result in not being able to vend on the Manatee County Fairgrounds.
